COVID-19 Updates, Protocols & Waiver

Pursuant to Executive Order No. 154 (Murphy) (June 13, 2020) and DCA Administrative Order 2020-09 (June 13, 2020), cosmetology shops, barber shops, beauty salons, hair braiding shops, nail salons, and massage establishments may reopen as of June 22, 2020.

Customers should be aware that these orders establish protocols requiring these facilities to implement operational safeguards to minimize person-to-person contact. These requirements include:

Salon will reopen for business on Wednesday, July 1, 2020. We understand that you are all eager to be rescheduled. To be fair to all, we are not scheduling any regular standard appointments, please call the salon to set up an appointment.

Waiver Requirement

Prior to you return to your return to the salon, please print and sign the attached waiver. Your appointment will be cancelled if the waiver is not executed prior to the start of any service.

New Protocols:

Pursuant to Executive Order No. 154 (Murphy) (June 13, 2020) and DCA Administrative Order 2020-09 (June 13, 2020), cosmetology shops, barber shops, beauty salons, hair braiding shops, nail salons, and massage establishments may reopen as of June 22, 2020.

Consumers should be aware that these orders establish protocols requiring these facilities to implement operational safeguards to minimize person-to-person contact.

Our plan is to go beyond what is recommended. We have consulted with other, very reputable salons, who have already opened their doors, to create our own safety protocols. The following list will outline those protocols as well as inform you of what to expect upon returning to the salon.

- Only customers receiving a service will be allowed in the salon.
- No more than 3 people will be allowed in the salon at any one time.
- We have set up an entry station for sanitation and communication upon arrival.

- Each area, all tools, stations and equipment will be sanitized and/or disinfected between each client.
- Masks will be mandatory and provided. Do not remove your mask during your visit.
- It is not mandatory to wear gloves as long as you are following hand sanitizing procedures.
- No sample products or testers will be available.
- All staff have updated certification on Sanitation protocols via Barbacide™ and OSHA.gov.
- Face/Eye protection will be worn by stylists during shampooing.
- Temporarily suspending all complimentary services; No beverages will be provided.
- Cleaner Air - Air purifiers will be placed around the salon.
- Cancellation/no-show policy- We will not be penalizing for any last-minute cancellations due to being sick. However, please provide us with information as soon as possible so we can adjust our schedules accordingly. We are trying our best to get every client back in as soon as possible.

Rest Assured, we hope to get back to a new normal and offering many of the added value services and extras you have come to enjoy

These protocols will continue to be refined and adjusted as needed and we will keep you informed every step of the way

Confirming your appointment- if you do not confirm 24hrs prior to your appointment you will lose your appointment and be charged \$25 or 25% of your total service cost. Please understand we have many clients waiting to get in to see us.
